A. Terms and conditions:

- Bidders are advised to study all technical and financial aspects, instructions, forms, terms and specifications carefully in the tender document. Failure to furnish all information required in the Tender Document or submission of a bid not substantially responsive to the Tender document in every respect will be at the Bidder's risk and may result in the rejection of the bid.
- The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders will be declared after technical evolution and the other bid documents will be unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in our college website www.vmmahavidyalaya.ac.in. No individual intimation will be given. Name of the qualified bidders will be displayed in the college website.
- The Principal, Vivekananda Mission Mahavidyalaya, Purba Medinipur, reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.



4. The eligibility criteria are given below: -

- A. Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover and at least 50% of which is from civil engineering construction works) equivalent to amount given below: The turnover will be indexed at the rate of interest 8% for a complete financial year.
- B. The applicant in the same name and style as prime contractor should have successfully completed at least one contract value of same type of work at least 60% for 1st Call, 50% for 2nd Call & 40% for 3rd Call of the proposed contract within the last 5 years.
- C. The Tendered should be submitted Photocopy of Income Tax return for the last 3 years, PAN, GST Registration certificate, GST Current Return, Trade license renewed for the current financial year. Professional TAX Certificate with Current Payment Certificate The tender inviting authority shall verify the above-mentioned documents (in original) which are mandatory for the participation before issuance of the work order paying slip of (EMD, bid document) should be furnished (Scan Copy).
- D. To qualify for a Package of contracts made up of this and other contracts for which bids are invited in the NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregates of the qualifying criteria for individual contracts.
- E. The amount of earnest money is 2% of the estimated cost for "Repairing work of Existing cycle stand of Vivekananda Mission Mahavidyalaya". All duties, taxes, royalties, Cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% Cess under W. B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills. Vivekananda Mission Mahavidyalaya, Purba Medinipur.
5. Payment of bill will be made through by crossed account payee Cheque or electronic payment (NEFT) or ePFMS portal by Print Payment Advices only after completion of scheduled work after deduction of 10% security or submission of bank guarantee and others taxes as per Govt. norms. Security deposit is refundable as per Govt. Rule.
6. Refund of EMD: The Earnest money of all the unsuccessful tenderers/bidders will be refunded after submission of application with original bank transaction slip from the tenderer/ bidders to the office of the Vivekananda Mission Mahavidyalaya, Purba Medinipur. The Earnest money deposited by the successful tenderer/bidders will be converted into security deposit. No interest will be paid by the tender accepting authority.
7. For Additional Performance Security Govt. of West Bengal F.D. AUDIT BRANCH Go No. 4608-F(Y)/, Dt. 18-07-2018 will be followed.
8. The security deposit will be repaid to the agency (contractor) after 1(one) year for Bituminous Work (Premix upto 20 mm thick), 3(three) year for Bituminous Work (above 40 mm thick), 5(five) year for Bituminous Work (covered by mastic), 1(one) year for Welcome Gate, Plantation & Electrical Work (i.e. defect liability period) and for building, culvert, drain & bridge, concrete road etc and 2 (two) year for submersible work, 5 (five) years for Solar/Solar power plant of satisfactory completion of the whole work, in case of failure to complete the work within the stipulated time or in any case of failure to rectify and defect arising during the security period penal measure will be taken and the security deposit will be forfeited and the contractor will be black listed.
- B. METHODOLOGY OF SUBMISSION OF BID AND ITS EVALUATION:**
- The Bidder has to accept unconditionally the on-line user portal agreement which contains the acceptance of all the Terms and Conditions of NIT, including Commercial and General Terms & Conditions and other terms, if any, along with on-line undertaking in support of the authenticity of the declarations regarding the facts, figures, information and documents furnished by the Bidder on-line in order to become an eligible Bidder. No conditional bid shall be allowed / accepted. The Bidder must comply with all the terms & conditions.






C. Confirmatory Documents:
